### Frequently Asked Questions about Joining the Junior League of Birmingham

**1. Do my Sponsors need to be Members of the JLB or can they be Members of any Junior League?**

*Sponsors will need to be Active or Sustainer Members of the Junior League of Birmingham specifically.*

**2. When you say that one of my three (3) Sponsors needs to be an “Active” or “Sustainer”, what does that mean?**

*An “Active” Member is one who is currently in good standing and volunteering their time and talents within the JLB. A “Sustaining” Member is one who has given ten (10) years of Active service and is in good standing. Please note, a Member who is currently in their Provisional Year or who is on Restricted Status is not eligible to be a Sponsor.*

**3. I am new to Birmingham and I don’t know anyone that is a Member of the JLB. How do I find Sponsors?**

*The admissions team will assist candidates in finding sponsors. Additionally, you can ask around at your workplace, place of worship, gym, alumni networking groups, etc. You can also check out Social Media: “Like” the JLB Facebook page, “Follow” us on Twitter, and check out our LinkedIn Profile.*

**4. What is the age criteria for Membership into the JLB?**

*In order to join the Provisional Class for 2019 - 2020, you must be at least 23 years of age by September 1, 2019.*

**5. I was an Active member of another League and have recently moved to Birmingham; Do I need to restart my Provisional year in order to become a Member of the JLB?**

*In most cases, if you have completed your Provisional year at another Junior League, you can Transfer your Membership. In order to Transfer your Membership, you must contact your current League and ask them to Transfer your Membership to the JLB, via the AJLI (Association of Junior Leagues International) e-Transfer system. **6. Where do I go to pay the Application Fee, complete the Application, and have my Sponsors complete the Sponsor form?**

**7. Define “Provisional” at the JLB:**

*Provisional Members are those Members who are engaged in training established by the League to prepare them for effective community and League involvement. Provisional Members are not eligible to vote, hold office, or Sponsor a candidate for Membership.*

### 8. What are the typical Provisional Financial requirements for the JLB?

*Total = \$368 (Provisional year only)*

- *\$150 Annual Dues*
- *\$130 One-Time Provisional Course Fee*
- *\$88.00 Fundraising quota (Market Noel quota and Shop, Save and Share Card)*

### 9. What are the typical Provisional Organizational & Community requirements for the JLB?

- *Attend Opening Retreat (Typically August)*
- *Attend Four (4) Provisional Meetings:*
  - *Two (2) in the Fall (Typically October and November)*
  - *Two (2) in the Winter/Spring (Typically January and March)*
    - *Typically the First or Last Tuesday of the month from 6 - 9 p.m.*
- *Attend Closing Session (Typically May)*
- *Complete the Provisional Mini-Placement (Currently Project Yummy - Mobile Teaching Kitchen)*
- *Two (2) Meeting Credits (e.g., General Membership Meetings, Member Trainings)*
- *Two (2) Credit Opportunities*
- *Three (3) 3-Hour Shiftwork Credits*
- *Donate \$100 worth of gently used household goods to Bargain Carousel fundraiser*
- *Register to Vote/Vote in Elections*

### 10. What are the typical Active requirements (Financial, Organizational, & Community) to maintain Membership in the JLB?

- *Annual Dues: Currently \$150*
- *Market Noel Quota: Currently \$48*
- *Meeting Credits (e.g., General Membership Meetings, Member Trainings):*
  - *Active Years 1 - 4: Two (2) Meeting Credits*
  - *Active Years 5 - 8: One (1) Meeting Credit*
  - *Active Years 9 - 10: Not required to complete a Meeting Credit*
- *Credit Opportunities:*
  - *Active Years 1 - 8: Two (2) Credit Opportunities*
  - *Active Years 9 - 10: One (1) Credit Opportunity*
- *Two (2) 3-Hour Shiftwork Credits:*
  - *Active Years 1 - 8: Two (2) 3-Hour Shiftwork Credits*
  - *Active Years 9 - 10: One (1) 3-Hour Shiftwork Credit*
- *One Placement Per Year: Typically 40 hours per year*
- *Donate \$100 worth of gently used household goods to Bargain Carousel Fundraiser*
- *Vote in Elections*
